Formally informed Parish Council and Hereford CC that we are intending to bid. Written to Planning and Conservation Dept.'s in Hereford to confirm our status re ACV Listing and condition of listed buildings.

Next Steps

Society status / Prospectus / Share offer – major points mainly set by Community Benefit Society rules

- Application in with FCA was a three week minimum for registration
- Initial officers are those that signed the FCA application will all resign at first agm but can apply for re-election
- Appointment of Society officers, terms, transition period, elections et al outlined and set in rules
- One member gets one vote (not dependent on holding)
- Freehold will be held asset locked for the community no capital gain for share holders - can reinvest in buildings (e.g. conversion of rooms for rent, museum out of single cell building etc.) or for other community benefit once reserves have been built up

Next Steps II

Share offer – raising capital to purchase Boot from Liquidator

- Min age of 16 (money laundering rules (!), will need to legally sign if want to redeem share holding and it's a pub business)
- Share value of £50 min holding of 5 shares (£250) with max £100,000
- 3 year min hold (except in exceptional circumstances), if need to redeem shares they are not tradable but come back to society to reissue
- Target to pay interest of 2.5% after first year of trading variable and subject to management committee ratification, up to max of 5%
- The Society will not run the pub but will set / negotiate terms and appoint a tenant who's business it will be. It will be run commercially and will not be unfair competition to other local businesses
- Prospectus coming (cannot be issued until fully registered) but for now we
 need to get idea level of financial support available to help us with the
 shares / loans / grants split we will need to have in full document
